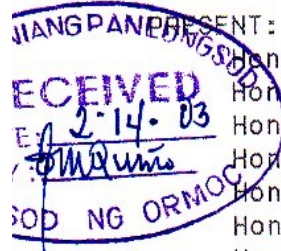

RESOLUTION NO. 2003-027

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR CARMELO J. LOCSIN TO ENTER INTO AND SIGN, A MEMORANDUM OF AGREEMENT WITH THE NATIONAL IRRIGATION ADMINISTRATION REPRESENTED BY ITS REGIONAL MANAGER ALEXANDER A. REUYAN, AND WITH THE BARANGAY COUNCIL OF BARANGAY AIRPORT, ORMOC CITY, REPRESENTED BY ITS BARANGAY CHAIRMAN, LEOPOLDO B. OMEGA, FOR THE DEVELOPMENT, REHABILITATION, OPERATION AND MAINTENANCE OF IRRIGATION SYSTEMS FACILITIES INCLUDING THE SERVICE ROADS, ACCESS ROADS AND FARM TO MARKET ROADS WITHIN ITS SERVICE AREA IN ORMOC CITY.

WHEREAS, this Sangguniang is in receipt of a letter dated 23 January 2003 from the Honorable City Mayor Carmelo J. Locsin, requesting for the passage of a resolution authorizing him to enter into and sign, a Memorandum of Agreement with the National Irrigation Administration and the Barangay Council of Barangay Airport, this city, for the development, rehabilitation, operation and maintenance of irrigation systems facilities including the service roads, access roads and farm to market roads within its service area in Ormoc City;

WHEREAS, said Memorandum of Agreement mentions of the task that NIA is mandated which is to develop, rehabilitate, operate and maintain irrigation facilities to improve irrigation services with the participation of the City Government of Ormoc and the barangay concerned;

WHEREAS, the Sangguniang Panlungsod ng Ormoc mindful of the benefits that will be derived therefrom, has considered said request reasonable, hence, the same be accorded due course of action;

WHEREFORE, foregoing premises considered, on motion of City Councilor Nepomuceno P. Aparis I, Chairman, Committee on Laws and Ordinances, jointly seconded by City Councilors Rafael C. Omega, Jr. and Gregorio A. Yrastorza, Jr.; be it




