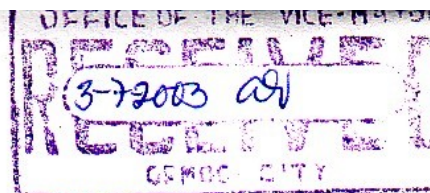

RESOLUTION NO. 2003-038

A RESOLUTION APPROVING BARANGAY ORDINANCE NO. 01-2003 SERIES OF 2003 OF THE BARANGAY COUNCIL OF BARANGAY ALEGRIA, THIS CITY, ENTITLED: "AN ORDINANCE AMENDING THE RATES ON THE ISSUANCE OF BARANGAY CLEARANCES, CERTIFICATES, PERMITS, FILING FEES AND OTHER CHARGES."

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance No. 01-2003 series of 2003 of the Barangay Council of Barangay Alegria, this city, entitled: "AN ORDINANCE AMENDING THE RATES ON THE ISSUANCE OF BARANGAY CLEARANCES, CERTIFICATES, PERMITS, FILING FEES AND OTHER CHARGES;"

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the aforecited ordinance at issue (and all other ordinances of the Sangguniang Barangay in Ormoc City), is by law, granted the Power of Review as to whether the said ordinance is consistent with law and city X X X ordinances; (Sec. 57, 1991 LGC)
