

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR CARMELO
J. LOCSIN, TO SIGN FOR AND IN BEHALF OF THE CITY
GOVERNMENT OF ORMOC, A DEED OF DONATION IN FAVOR OF
BARANGAY ALEGRIA INVOLVING A PARCEL OF LAND LOT NO.
2513-PART WITH AN AREA OF 1,500 SQ. M. MORE OR LESS, TO
BE USED AS BARANGAY SITE.

WHEREAS, this Sanggunian is in receipt of 3rd Indorsement dated 07
February 2003 from the Secretary to the City Mayor requesting for a
passage of a resolution authorizing the City Mayor to sign a Deed of
Donation for and in behalf of the City Government of Ormoc for a parcel
of land in favor of Barangay Alegria for purposes of their barangay
site;


