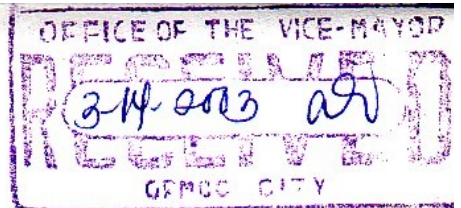
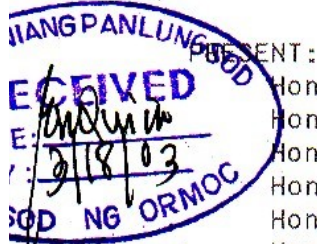

RESOLUTION NO. 2003-047

A RESOLUTION ALLOWING BARANGAY DISTRICT XVII, ORMOC CITY TO USE A PARCEL OF LAND WHICH IS AN ABANDONED PORTION OF LOPEZ JAENA STREET WHICH IS WITHIN THE JURISDICTION OF THE BARANGAY AS A LOCATION SITE OF THE BARANGAY HALL, DAY CARE CENTER AND VARIOUS INFRASTRUCTURE PROJECTS, WITH THE PREMISE THAT IT SHALL CONFORM WITH THE EXISTING LAND USE PLAN OF THE CITY.

WHEREAS, this Sanggunian is in receipt of 4th Indorsement dated 03 March 2003 from the Office of the City Mayor re: request of the Barangay Council of Brgy. District XVII, Osmo city, to use an abandoned parcel of land within the jurisdiction of said district as a location site for various barangay infrastructure projects;


