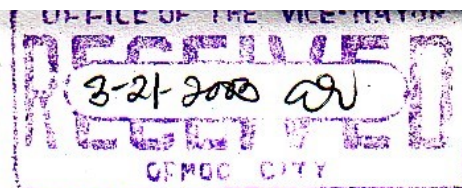

by City Councilor Gregorio A. Yrastorza, Jr.; be it


RESOLVED, to pass an omnibus resolution APPROVING THE APPLICATION


RESOLVED, FURTHER, to furnish copies of this resolution each to His
