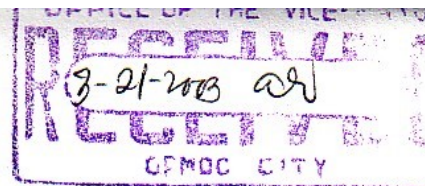
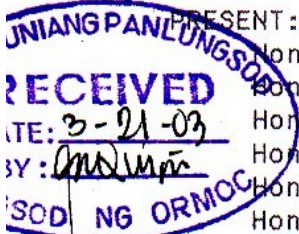



ADOPTED, March 20, 2003.


