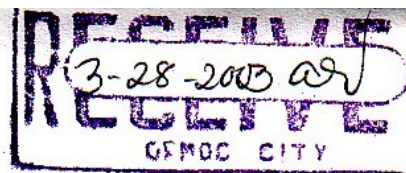
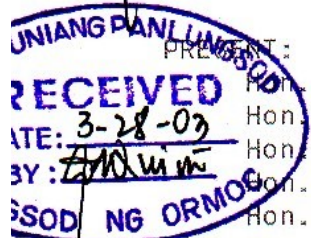

A RESOLUTION APPROVING TAX ORDINANCE NO. 03-01 SERIES OF
2003 OF THE BARANGAY COUNCIL OF TONGONAN, ORMOC CITY,
ENTITLED: "AN ORDINANCE IMPOSING TAXES, FEES AND
CHARGES ON ESTABLISHMENTS FOR BUSINESS OR THE LIKE
OPERATING WITHIN BARANGAY TONGONAN".

WHEREAS, this Sangguniang is in receipt of Barangay Tax Ordinance
No. 03-01 S. 2003 from the Sangguniang Barangay of Brgy. Tongonan,
Ormoc City, entitled: "AN ORDINANCE IMPOSING TAXES, FEES AND CHARGES ON
ESTABLISHMENTS FOR BUSINESS OR THE LIKE OPERATING WITHIN BARANGAY
TONGONAN";

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the
