A RESOLUTION APPROVING TAX ORDINANCE NO. 03-01 SERIES OF 2003 OF THE BARANGAY COUNCIL OF TONGONAN, ORMOC CITY, ENTITLED: AN ORDINANCE IMPOSING TAXES, FEES CHARGES ON ESTABLISHMENTS FOR BUSINESS OR THE LIKE OPERATING WITHIN BARANGAY TONGONAN".

WHEREAS, this Sangguniang is in receipt of Barangay Tax Ordinance No. 03-01 S. 2003 from the Sangguniang Barangay of Brgy. Tongonan, Ormoc City, entitled: "AN ORDINANCE IMPOSING TAXES, FEES AND CHARGES ON ESTABLISHMENTS FOR BUSINESS OR THE LIKE OPERATING WITHIN BARANGAY TONGCHAN";

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the aforecited Ordinance at issue (and all other ordinances of the Sangguniang Barangay in Ormoc City) is, by law, granted the Power of Review as to whether the said ordinance is consistent with the law and city X X X ordinances; (Sec. 57, 1991 LGC)
