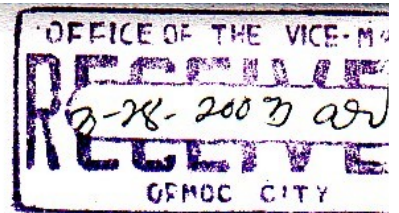
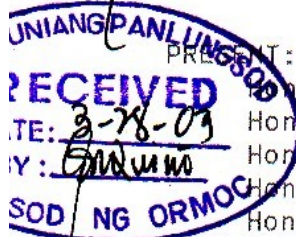

A RESOLUTION APPROVING TAX ORDINANCE NO. 01 SERIES OF
2003 OF THE BARANGAY COUNCIL OF BARANGAY AIRPORT, ORMOC
CITY, ENTITLED: "AN ORDINANCE CHARGING A FEE ON THE USE
OF THE BARANGAY BASKETBALL COURT, OR IN ANY PORTION OF

AND OTHER SIMILAR MATERIALS".

WHEREAS, this Sangguniang is in receipt of Barangay Tax Ordinance
No. 01 S. 2003 from the Sangguniang Barangay of Brgy. Airport, Ormoc
City, entitled: "AN ORDINANCE CHARGING A FEE ON THE USE OF THE BARANGAY

Ordinances, duly seconded by City Councilor Jose S. Serafica; be it


