RESOLUTION APPROVING TAX ORDINANCE NO. 01 SERIES OF 2003 OF THE BARANGAY COUNCIL OF BARANGAY AIRPORT, ORMOC CITY ENTITLED: "AN ORDINANCE CHARGING A FEE ON THE USE OF THE BARANGAY BASKETBALL COURT, OR IN ANY PORTION OF THE BARAKGAY MULTI-PURPOSE PAVEMENTS FOR DRYING GRAINS AND OTHER SIMILAR MATERIALS".

WHEREAS, this Sangguniang is in receipt of Barangay Tax Ordinance 01 S. 2003 from the Sangguniang Barangay of Brgy. Airport, entitled: "AN ORDINANCE CHARGING A FEE ON THE USE OF THE BARANGAY BASKETBALL COURT, OR ANY PORTION OF THE BARANGAY MULTI-PURPOSE PAVEMENTS FOR DRYING GRAINS AND OTHER SIMILAR MATERIALS";
