A RESOLUTION REQUESTING THE REGIONAL MANAGER OF
PHILIPPINE PORTS AUTHORITY (PPA) TACLOBAN CITY, TO
FAST-TRACK THE PUTTING UP OF A PEDESTRIAN LANE AT THE
ORMOC PORT.

WHEREAS, at present the port of Ormoc is becoming one of the busy
ports in the Visayas considering that it serves as a jump-off point to
passengers bound for the neighboring visayan islands and to Metro
Manila;

WHEREAS, as precautionary measure, it would be proper that a
pedestrian lane be established in the said port to avoid accidents to
happen especially to passengers;

WHEREAS, it can be recalled, that a male passenger was hit by a
cargo truck sometime February of this year and it could have been
prevented if a pedestrian lane was established;

WHEREAS, the said project can enhance orderliness at the said port
and provide commuters a safer passage way whenever they come in and
leave the port area;

WHEREFORE, foregoing premises considered, on motion of City
Councilor Jovencio A. Laurente, Chairman, Committee on Transportation &
Communications, severally seconded by City Councilors Eduardo P. Tan, Fe
S. Lladoc and Rafael C. Omega, Jr.; be it


