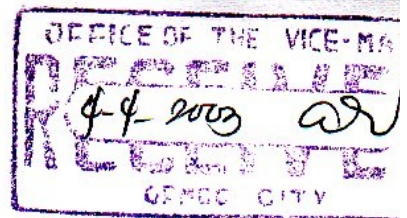

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR CARMELO J. LOCSIN TO SIGN A MEMORANDUM OF AGREEMENT (MOA) TO BE ENTERED INTO BETWEEN THE NATIONAL IRRIGATION ADMINISTRATION, THE CITY GOVERNMENT OF ORMOC AND BARANGAY SAN JOSE, FOR THE REHABILITATION AND IMPROVEMENT OF SERVICE ROADS.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 21 March 2003 from the Honorable City Mayor Carmelo J. Locsin, requesting for the passage of a resolution authorizing him to enter into and sign a Memorandum of Agreement (MOA) by and among the National Irrigation Administration, the City Government of Ormoc and Barangay San Jose, for the rehabilitation and improvement of service roads;


