

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR CARMELO
J. LOCSIN TO GIVE ADDITIONAL ALLOWANCE TO ATTY. ALBERTO
L. CONOPIO AS ACTING CITY LEGAL OFFICER, THIS CITY, IN
THE AMOUNT OF TWO THOUSAND SEVEN HUNDRED PESOS
(P2,700.00) A MONTH.

WHEREAS, City Prosecutor Alberto L. Conopio has been requested by
the Honorable City Mayor Carmelo J. Locsin to act as City Legal Officer
vice Atty. Ari G. Larrazabal who resigned and pending the designation of
a regular City Legal Officer;

WHEREAS, as Acting City Legal Officer, it is understood that he has
to represent the City in any legal undertakings before any court, board
or body wherein the City of Ormoc is a party thereto as well as
rendering resolution and legal opinion on any matters referred to him;

WHEREAS, the Honorable City Mayor through a letter addressed the
Hon. Alberto L. Conopio dated 21 January 2003 has stated that: "You are
hereby entitled to whatever allowances as allowed by law";

WHEREAS, this august Body believes that granting of additional
allowance is valid and reasonable taking into consideration the volume
of work entrusted to him as Acting City Legal Officer, this city;
