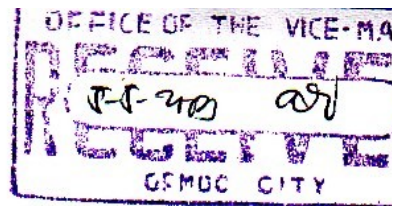


ADOPTED, April 30, 2003.


