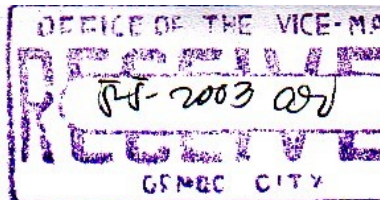

A RESOLUTION EARNESTLY REQUESTING THE MANAGEMENT OF
LEYECO V TO ALLOW THE CHAIRMAN COMMITTEE ON ENERGY OF
THE SANGGUNIANG PANLUNGSOD NG ORMOC OR HIS AUTHORIZED
REPRESENTATIVE TO PARTICIPATE IN ITS BOARD MEETINGS
SPECIALLY ON MATTERS AFFECTING PUBLIC INTEREST.

WHEREAS, on its pre-session caucus on April 28, 2003, the
Sangguniang Panlungsod ng Ormoc invited LEYECO V Manager Mr. Jovencio R.
Alesna who was represented by Mr. Jorda and Mr. Boldios, regarding the
frequent brown-outs in the city including the non-implementation of the
2% discount on prompt payments made by consumers and the Eighty Pesos
(P80.00) reconnection fee charged by LEYECO V whether or not a
disconnection is made;

WHEREAS, most consumers are greatly bothered by these issues and
are clamoring for a clarification regarding the same;

WHEREAS, with this development, this august Body feels it necessary
and imperative to represent the consumers to the Board of LEYECO V
especially on matters affecting public interest, hence, this request;

Councilor Demosthenes F. Tugonon, severally seconded by City Councilors
