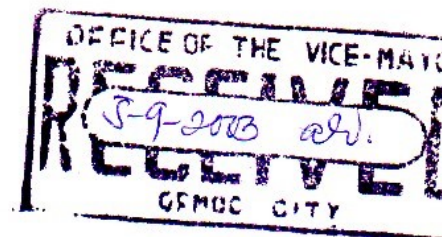
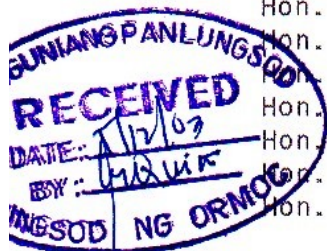

A RESOLUTION EARNESTLY REQUESTING THE DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE) REGION VIII THRU ITS OIC - REGIONAL DIRECTOR, ATTY. RODOLFO M. SABULAO, TO EXPEDITE THE SETTLEMENT OF THE LABOR DISPUTE BETWEEN THE MANAGEMENT AND THE EMPLOYEES UNION (SEGAO) OF GAISANO ORMOC.

WHEREAS, at present, there is an existing labor dispute between the management and the employees union (SEGAO) of Gaisano Ormoc;

WHEREAS, it has been known that both parties are suffering from economic setback and some are afraid that they might lose their jobs;

WHEREAS, in order not to aggravate the situation, this august Body believes that a speedy disposition of this existing labor dispute is appropriate, hence, this request;
