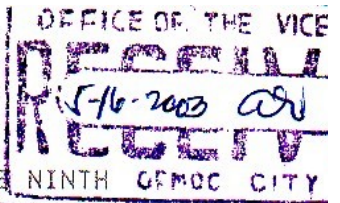

THE SUPPLEMENTAL BUDGET NO. 03 CY 2003 OF BARANGAY MILAGRO, ORMOC CITY;



Chairman/Treasurer of the Barangay Milagro, -all in Ormoc City;


