RESOLUTION NO. 2003-082

A RESOLUTION APPROVING THE REQUEST OF BARANGAY DISTRICT 01 TO CONSTRUCT INFRASTRUCTURE PROJECT ON A 34 SQ. METERS GOVERNMENT-OWNED LOT WITHIN THE SAID DISTRICT.

WHEREAS, this Sangguniang is in receipt of 4th Indorsement dated 28 April 2003 from the Hon. City Mayor Carmelo J. Locsin requesting this august Body for concurrence and approval relative to Barangay Resolution No. 05 of Barangay District 01, entitled: "A RESOLUTION EARNESTLY REQUESTING THE CITY GOVERNMENT THRU THE CITY MAYOR CARMELO J. LOCSIN FOR PERMISSION TO CONSTRUCT INFRASTRUCTURE PROJECT AT THE THIRTY FOUR SQUARE METERS (34.0 SQ. M.) LOT RECLAIMED OUTSIDE THE JICA FENCE WITHIN THE JURISDICTION OF BARANGAY DISTRICT 01, ORMOC CITY";

WHEREAS, Planning Officer IV, Engr. Dario D. Sarit through 2nd Indorsement dated 19 March 2003 has stated that, "Per verification and inspection conducted, this Office finds that the lot is a vacant public land and therefore can be utilized for the proposed use. Further it is advised that District 01 shall maximize the use of said lot, considering the available area of only 34 sq. m.";

WHEREAS, the City Prosecutor/Acting City Legal Officer through 7th Indorsement dated 7 May 2003, has opined that "the utilization of said 34 sq. m. government-owned vacant lot within the said district is reasonable and purposeful";

WHEREFORE, foregoing premises considered, on motion of City Councilor Nepomuceno P. Aparis I, Chairman, Committee on Public Properties, severally seconded by City Councilors Fernando P. Parrilla, Ruviniou E. Mendola and Gregorio A. Yrastorza, Jr.; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution APPROVING THE REQUEST OF BARANGAY DISTRICT 01 TO CONSTRUCT INFRASTRUCTURE PROJECT ON A 34 SQ. METERS GOVERNMENT-OWNED LOT WITHIN THE SAID DISTRICT;
