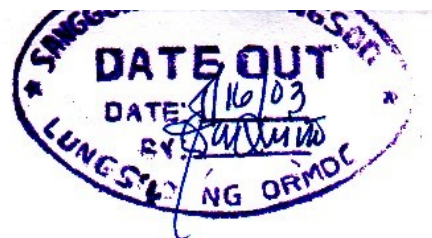
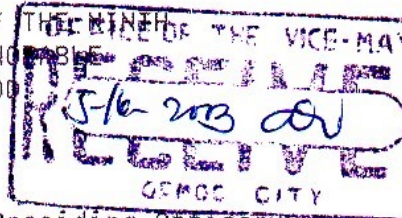

RESOLUTION NO. 2003-083

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR CARMELO J. LOCSIN TO ENTER INTO AND SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC THE ATTACHED MEMORANDUM OF AGREEMENT (MOA) FOR THE RENEWAL OF THE COMMUNITY MILK FEEDING PROGRAM WITH THE NATIONAL DAIRY AUTHORITY (NDA) REPRESENTED BY ITS ADMINISTRATOR, SALVACION M. BULATAO AND THE OCCIDENTAL LEYTE DAIRY PRIMARY MULTI-PURPOSE COOPERATIVE (OLDAPRIMCO) REPRESENTED BY ITS CHAIRMAN, ENGR. JESUS N. VILLAMIL FOR CY 2003.

WHEREAS, this august Body is in receipt of a letter dated 24 April 2003 from the Honorable City Mayor Carmelo J. Locsin, requesting for a resolution authorizing him to enter into and sign for and in behalf of the City Government of Ormoc, a memorandum of agreement (MOA) for the Renewal of the Community Milk Feeding Program with the National Dairy Authority (NDA) represented by its administrator, Salvacion M. Bulatao and the Occidental Leyte Dairy Primary Multi-Purpose Cooperative (OLDAPRIMCO) represented by its Chairman, Engr. Jesus N. Villamil, for CY 2003;

WHEREAS, said Memorandum of Agreement (MOA) states that, the Department of Agriculture through the National Dairy Authority (NDA) implements its dairy program along two objectives: pursuing a Milk Feeding Program to improve nutrition among children and at the same time promoting dairying as livelihood for rural farmers;

WHEREAS, the LGU-Ormoc through the Operation Timbang (OPT) of its City Health Office has identified within the city, a total of 210 malnourished pre-schoolers from 8 barangays which are the priority target beneficiaries for a Community Milk Feeding Program;

WHEREAS, the LGU-Ormoc, from its City Social Welfare and Development (CSWD) Supplemental feeding fund has allotted ONE HUNDRED THOUSAND EIGHT HUNDRED PESOS (P100,800.00) for 105 malnourished preschoolers and the National Dairy Authority (NDA) has also agreed to provide counterpart funds in the same amount for the remaining 105 malnourished preschoolers to serve the total 210 identified beneficiaries for the implementation of said Community Milk Feeding Program for 120 days from May 2003 to October 2003;

WHEREAS, this august Body has considered said request reasonable and beneficial, hence, same is accorded due course of action;

WHEREFORE, on motion of City Councilor Fe S. Lladoc, Chairman, Committee on Social Welfare, Women & Family, severally seconded by City Councilors Rafael C. Omega, Jr., Gregorio A. Yrastorza, Jr. and Cheryl L. Alfar; be it
