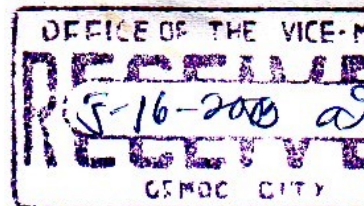

THIS CITY, IN THE AMOUNT OF TWO THOUSAND SEVEN HUNDRED
PESOS (P2,700.00) A MONTH"; THEREBY GRANTING THE SAME
EFFECTIVE JANUARY 2003.

WHEREAS, this august Body passed Resolution No. 2003-068 dated 24
April 2003 entitled, "A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR


