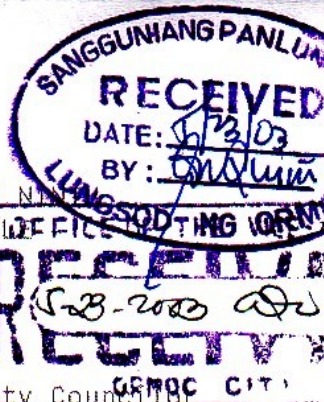


ADOPTED, May 22, 2003.
