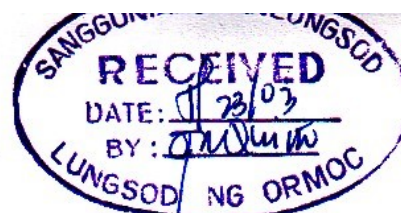
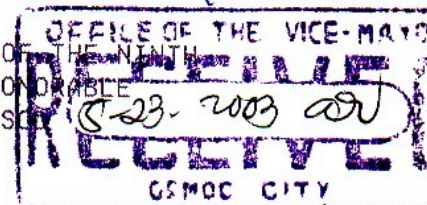

A RESOLUTION REQUESTING THE PROVINCIAL HEALTH OFFICER AND  
THE GOVERNOR OF THE PROVINCE OF LEYTE TO ASSIGN A  
SURGEON/S TO THE ORMOC DISTRICT HOSPITAL.

WHEREAS, the Ormoc District Hospital (ODH) a medical institution  
under the administrative and managerial jurisdiction of the Province of  
Leyte, has been rendering medical services to the residents of Ormoc  
City as well as its neighboring municipalities;

WHEREAS, lately however, it has come to the knowledge of this  
august Body that said hospital is in need of the services of a surgeon  
in view of the reason that one doctor has resigned and another one is on  
leave;

WHEREAS, it is of public knowledge that health is one of the prime  
concern of the present administration thus, answering the problem that  
is presently experienced by ODH is but timely and reasonable so as not  
to defeat the purpose for which said institution was created;

Aparis I; be it


RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution REQUESTING
