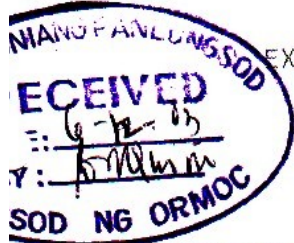
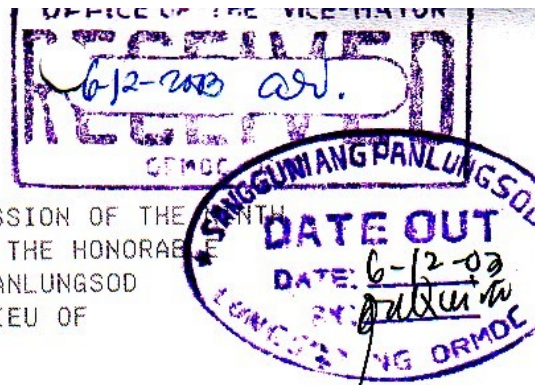


ADOPTED, June 11, 2003.


