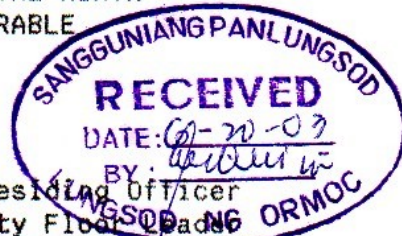

RESOLUTION NO. 2003-101

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR CARMELO J. LOCSIN, TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, A COLLECTIVE NEGOTIATION AGREEMENT (CNA) WITH THE CITY ORMOC GOVERNMENT EMPLOYEES ASSOCIATION (COGEA).

WHEREAS, this august Body is in receipt of 3rd Indorsement dated 06 May 2003 from the Honorable City Mayor Carmelo J. Locsin requesting for authority to sign for and in behalf of the City Government of Ormoc, the Collective Negotiation Agreement with the City of Ormoc Government Employees Association (COGEA), further requesting that the same be treated as urgent;

WHEREAS, having conferred upon said association (COGEA) the right to be certified subject to the conditions, prescribed by law, as the sole representative by the rank and file employees to negotiate and undertake activities not contrary to law or public policy, a Collective Negotiation Agreement (CNA) is presented, defining the stand of both parties;

WHEREAS, finding said proposal to be meritorious and in order, per 2nd Indorsement of the Acting City Legal Officer dated 05 May 2003, this Sanggunian believes that the request of the Honorable City Mayor is reasonable, hence, the same be accorded the necessary course of action;

WHEREFORE, foregoing premises considered, on motion of City Councilor Ruviniou E. Mendola, Chairman, Committee on Agricultural and Industrial Labor, duly seconded by City Councilor Jose S. Serafica; be it
