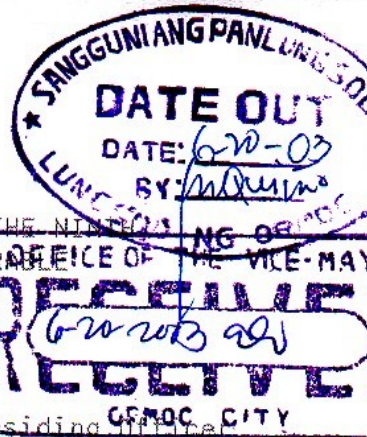



ADOPTED, June 19, 2003.


