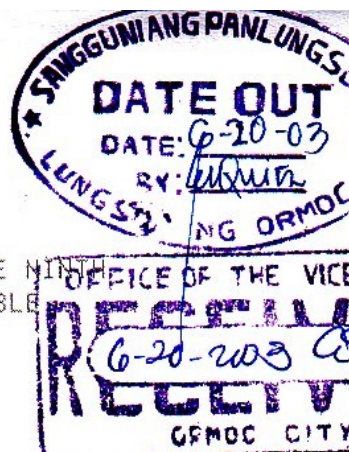

A RESOLUTION AUTHORIZING THE CITY ACCOUNTANT TO CHARGE TO
CURRENT APPROPRIATION THE OUTSTANDING OBLIGATION ON
POWER AND ILLUMINATION CONSUMPTION OF VARIOUS PUBLIC
BUILDINGS FOR CALENDAR YEAR 1999, 2000, 2001 AND 2002
IN THE TOTAL AMOUNT OF FORTY THREE THOUSAND SEVEN
HUNDRED FIFTY SIX PESOS & 12/100 (P43,756.12).

WHEREAS, this Sanggunian is in receipt of a letter dated 02 June
2003 from the OIC-General Services Office requesting for a resolution
authorizing the City Accountant to charge to current appropriation the
outstanding account on power and illumination consumption of various
public building for calendar year 1999, 2000, 2001 and 2002 in the total
amount of FORTY THREE THOUSAND SEVEN HUNDRED FIFTY SIX PESOS & 12/100
(P43,756.12);

WHEREAS, considering that said obligations were incurred way back
1999, 2000, 2001 and 2002, the same has been recommended to be charged
