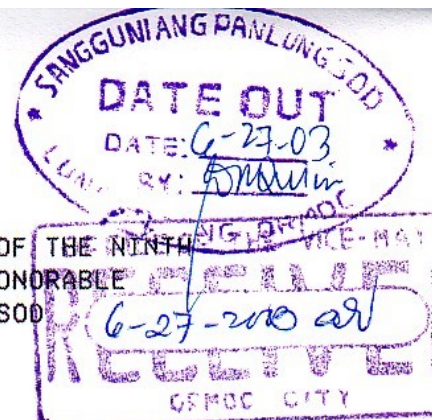



ADOPTED, June 26, 2003.


