MANAGEMENT CORPORATION (LMC) TO THE NATIONAL WATER RESOURCES BOARD (NWRB).

WHEREAS, the Leyte Industrial Development Estate (LIDE) Management Corporation (LDC) has applied for a new water permit with the National Water Resources Board (NWRB) to draw and extract water;

WHEREAS, this new water permit application of LIDE will bring to total extraction of about 516 liters per second which is even more than the total demand of the service areas of the Ormoc City waterworks system for the coming 15 years;

WHEREAS, it is the observation of this august Body that said extraction will adversely affect the level of the aquafer of said area and eventually no more potable water supply will be left for our own

WHEREAS, considering that the period to file an opposition to the said application is only thirty (30) days from June 12, 2003 which is the date of posting of notice, this august body believes that the same be acted upon, hence this request;
