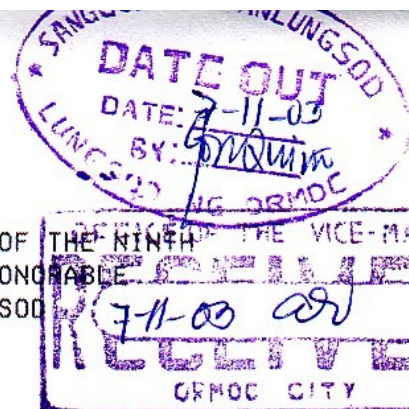
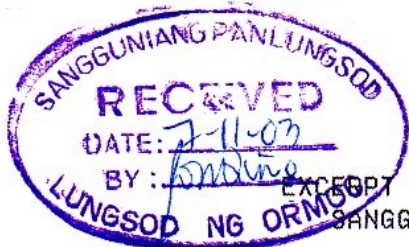

RESOLUTION NO. 2003-114

A RESOLUTION AUTHORIZING THE CITY ACCOUNTANT TO CHARGE AGAINST CURRENT APPROPRIATION FOR OTHER EXPENSES OF THE CITY HEALTH OFFICE, THE AMOUNT OF NINE HUNDRED SIXTEEN PESOS AND 15/100 (P916.15) TO SETTLE UNPAID ACCOUNT WITH LEYECO V FOR THE INSTALLATION OF ONE (1) UNIT ELECTRIC METER.

WHEREAS, this Sanggunian is in receipt of 4th Indorsement dated 17 June 2003 from the Honorable City Mayor Carmelo J. Locsin re: request to authorize the City Accountant to charge the amount of NINE HUNDRED SIXTEEN PESOS & 15/100 (P916.15) against current appropriation for other expenses of the City Health Office to settle unpaid account with LEYECO V for the installation of one (1) unit electric meter per letter of Dr. Rogelio G. Marson, City Health Officer, this city;

WHEREAS, the City Budget Officer through 2nd Indorsement dated 10 June 2003 has stated that said obligation be sourced against current appropriation for other expenses of the City Health Office, this city;
