RESOLUTION NO. 2003-124

A RESOLUTION DECLARING ORMOC CITY UNDER THE "STATE OF
CALAMITY" DUE TO THE EXTENT OF DAMAGE CAUSED BY TYPHOON
"GILAS".

WHEREAS, this august body is in receipt of 1st Indorsement dated 21
July 2003 from the Office of the City Mayor re: documents pertaining to
the extent of damage caused by typhoon "GILAS" and Resolution No. 3 s.
2003 of the City Disaster Coordinating Council (CDCC) entitled: "A
RESOLUTION RECOMMENDING TO THE SANGGUNIANG PANLUNGSOD THRU THE CITY
CHIEF EXECUTIVE, MAYOR CARMELO J. LOCSIN, FOR THE DECLARATION OF A
"STATE OF CALAMITY" IN ORMOC CITY IN CONNECTION WITH TYPHOON "GILAS";

WHEREAS, the authority to determine and declare an area or a
portion thereof as calamity area is vested solely on the local
sanggunian concerned as provided for by Sec. 1 of Republic Act No. 8185
entitled: "AN ACT AMENDING SECTION 524 (d) OF REPUBLIC ACT NO. 7160
OTHERWISE KNOWN AS THE LOCAL GOVERNMENT CODE OF 1991", dated June 11,
1996 and quoted hereunder as follows:

"SECTION 1. Section 324(d) of Republic Act No. 7160 is
hereby amended to read as follows:

(d) Five percent (5%) of the estimated revenue from regular
sources shall be set aside as annual lumpsum
appropriations for the relief, rehabilitation,
reconstruction and other works or services in connection
with calamities which may occur during the budget year,
provided, however, that such fund shall be used only in
the area or portion thereof of the Local Government Unit
or other areas affected by a disaster or calamity, as
determined and declared by the local sanggunian
concerned";

WHEREAS, the Sangguniang Panlungsod ng Ormoc mindful of the plight of its constituents especially those areas greatly affected by said typhoon, has considered said recommendation reasonable, hence, the same be accorded the necessary course of action;

WHEREFORE, foregoing premises considered, on MASS MOTION of the Body; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution DECLARING ORMOC CITY UNDER THE "STATE OF CALAMITY" DUE TO THE EXTENT OF DAMAGE CAUSED BY TYPHOON "GILAS";

ADOPTED, July 24, 2003.
