RESOLUTION NO. 2003-126

RESOLUTION INFORMING THE HONORABLE CITY MAYOR CARMELO J. LOCSIN THAT THE CONSENSUS OF THE MEMBERS OF THE 9TH SANGGUNIANG PANLUNGSOD IS THAT PHASE II AND PHASE III OF THE ORMOR CITY HALL CONSTRUCTION PROJECT SHOULD BE FUNDED OUT OF LOCAL FUNDS BASED ON THE ORIGINAL APPROVED PROJECT PROPOSAL.

WHEREAS, this Sanggunian is in receipt of a letter dated 16 May 2003 From the Honorable City Mayor Carmelo J. Locsin requesting for the passage of a resolution authorizing him to negotiate a loan with financial institutions for the construction of the Second and Third Phase of the City Government (City Hall) Building, this city;

WHEREAS, it is the consensus of this august Body that said mequest cannot be acted upon in view of the following reasons to wit:

- Based on the audit report, the City has not yet complied with COA Circular No. 89-229 dated March 21, 1989.
- Contracting a loan to finance a non-income generating project is not advisable, since this is a multi-million project, a more realistic programming should be done over a period of time.
- That the original project proposal calls for funding of the _project to be sourced out of local funds.
- We should use our own financial resources.



- 5. While there is a need for a new City Hall Building the same is not immediate or urgent which allows for a more rational programming of the project based on available financial resources.
- 6. Construction of the new City Hall Building is not crucial to the efficient and effective functioning of the City Government and therefore would not warrant the availment of a loan facility to finance the City Hall project.

WHEREFORE, foregoing premises considered, on motion of City Councilor Rafael C. Omega, Jr., Chairman, Committee on Finance, duly seconded by City Councilor Fernando P. Parrilla; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution informing the Honorable city mayor carmelo J. Locsin that the consensus of the members of the 9th sangguniang panlungsod is that phase II and phase III of the ormoc city hall construction project should be funded out of Local funds based on the original approved project proposal;

ADOPTED, July 31, 2003.

RESOLVED, FURTHER, to furnish copies of this resolution each to His Honor, the City Mayor, the City Administrator, the City Treasurer, the City Planning & Development Office, the City Engineer and others concerned, -in Ormoc City.
