A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR CARMELO J. LOCSIN TO SIGN THE MEMORANDUM OF AGREEMENT FOR THE ESTABLISHMENT OF AN APPLIED ACADEMICS FOR EXCELLENCE (APEX) LEARNING PROGRAM IN THE DIVISION OF ORMOC CITY IN THE EVENT THE CITY GOVERNMENT ALLOCATES FUND FOR THE PURPOSE.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 24 July 2003 from the Honorable City Mayor re: copy of the Memorandum of Agreement and Ormoc City Local School Board Resolution No. 2003-05 entitled: "A RESOLUTION REQUESTING THE CITY GOVERNMENT OF ORMOC TO ALLOCATE FUNDS AMOUNTED TO 1.2 MILLION PESOS AND TO AUTHORIZE THE HONORABLE CARMELO J. LOCSIN, CITY MAYOR TO SIGN THE MOA FOR THE ESTABLISHMENT OF AN APPLIED ACADEMICS FOR EXCELLENCE (APEX) LEARNING PROGRAM IN THE DIVISION OF ORMOC CITY";

WHEREAS, the New ormoc City National High School (NOCNHS) of Ormoc City Division has been chosen as the recipient in the establishment of an Applied Academic for Excellence (APEX), a learning program supported by the Southeast Asian Minister of Education Organization (SEAMEO) through the Regional Center for Educational Innovation and Technology (INNOTECH) based in Quezon City;

WHEREAS, said Memorandum of Agreement mentions of the Local Government Units (LGU's) counterpart in the amount of 1.2 Million to effect the implementation of the said program which will provide a comprehensive hands-on teaching and learning approach in science and mathematics that will equip our students with firm academic foundation;
