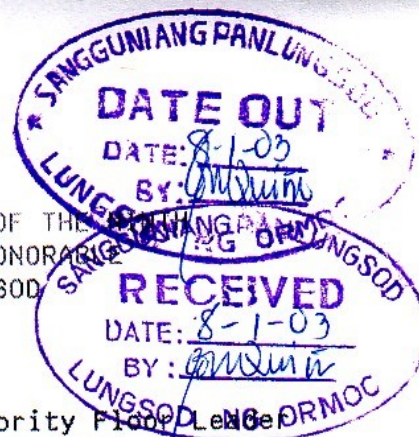

RESOLUTION NO. 2003-131

A RESOLUTION CONCURRING THE MEMORANDUM OF AGREEMENT
ENTERED INTO BETWEEN THE CITY GOVERNMENT OF ORMOC,
REPRESENTED BY THE HONORABLE CITY MAYOR CARMELO J.
LOCSIN, AND THE DEPARTMENT OF HEALTH-CENTER FOR HEALTH
DEVELOPMENT FOR EASTERN VISAYAS (CHD-EV), REPRESENTED
BY MILAGROS B. BACUS, MD. MPH, CESO III DIRECTOR IV.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 01
July 2003 from the Honorable City Mayor Carmelo J. Locsin copy of
Memorandum of agreement by and between the Department of Health-Center
for Health and Development and the City of Ormoc and requesting for
concurrence of the same;

WHEREAS, said Memorandum of Agreement mentions that the DOH-CHD
shall release the amount of ONE MILLION PESOS (P1,000,000.00) to the
City of Ormoc (LGU) through the Honorable City Mayor Carmelo J. Locsin,
who hereby accepts the said amount to be utilized for the purchase of
drugs & medicines, medical, dental and laboratory supplies for the use
of the LGU from DOH accredited suppliers;

WHEREAS, this august Body believes that said amount is of great
help to the City of Ormoc in its health and sanitation program, hence,
the same be accorded the necessary course of action, Provided, however,
that 70% of which will be allocated for drugs & medicines, 30% for
medical, dental, laboratory supplies and that the allocation for drugs &
medicines shall be procured from the list of medicines available at the
Philippine Trading Corporation, a government corporation;

WHEREFORE, foregoing premises considered, on motion of Rafael C. Omega, Jr., Chairman, Committee on Health, severally seconded by City Councilors Jovencio A. Laurente, Fe S. Lladoc & Fernando P. Parrilla; be it


