Omega, Jr. & Jovencio A. Laurente; be it


RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution APPROVING

ADOPTED, August 07, 2003.


RESOLVED, FURTHER, to furnish copies of this resolution each to His
