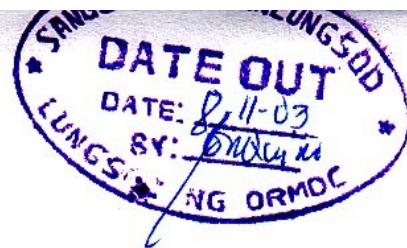

RESOLUTION NO. 2003-136

A RESOLUTION EARNESTLY REQUESTING THE HONORABLE CITY
MAYOR CARMELO J. LOCSIN TO COMPLY WITH THE COMMENTS AND
OBSERVATIONS OF THE COMMISSION ON AUDIT CONTAINED IN
THEIR ANNUAL AUDIT REPORT FOR CY 2002 PARTICULARLY THE
USE AND THE MARKING OF GOVERNMENT VEHICLES WITH "FOR
OFFICIAL USE ONLY" UNDER WHICH SHOULD BE WRITTEN THE
CORRESPONDING NAME OF THE OFFICE OPERATING OR USING THE
SAME.

WHEREAS, the use of Government motorcycles and motor vehicles of
the City Government of Ormoc have been abused by some vehicle users to
the extent of using them as if they are privately owned;

WHEREAS, it has come to the knowledge of this august Body that even
during Saturdays, Sundays and Holidays, City Government vehicles are
used in attending to private gatherings going to the beach and other
personal use, notwithstanding the fact that some are not marked "FOR
OFFICIAL USE ONLY" and others with temporary plate numbers;

WHEREAS, quoted hereunder is a portion of the Annual Audit Report
for 2002 of the Commission on Audit which states that:

"In the two (2) offices alone selected for sampling based on
the partial list furnished by the General Services Department, ten
(10) service motorcycles and nine (9) service vehicles did not have
the marking required. Of the ten motorcycles, nine had no plate
numbers while the other one had a blue plate number. For the
service vehicle, some had green colored plates instead of the red
ones. This could lead to indiscriminate use of the government
vehicles using gasoline and fuel of the City Government";

WHEREAS, the report further stated that "all motor vehicles owned by the government should be plainly marked "FOR OFFICIAL USE ONLY" under which should be written the corresponding name of the office operating or using the same. These should also bear government plates only, with the exception of security vehicles exempt from using the same";

WHEREAS, this august Body believes that findings of the Commission on Audit in its Annual Audit Report for 2002 must be strictly followed for the betterment of this city and good governance;

WHEREFORE, foregoing premises considered, on motion of City Councilor Demosthenes F. Tugonon, Vice-Chairman, Committee on Public Properties, jointly seconded by City Councilors Rafael C. Omega, Jr. and Fernando P. Parrilla; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution EARNESTLY REQUESTING THE HONORABLE CITY MAYOR CARMELO J. LOCSIN TO COMPLY WITH THE COMMENTS AND OBSERVATIONS OF THE COMMISSION ON AUDIT CONTAINED IN THEIR ANNUAL AUDIT REPORT FOR CY 2002 PARTICULARLY THE USE AND THE MARKING OF GOVERNMENT VEHICLES WITH "FOR OFFICIAL USE ONLY" UNDER WHICH SHOULD BE WRITTEN THE CORRESPONDING NAME OF THE OFFICE OPERATING OR USING THE SAME;
