RESOLUTION NO. 2003-139

A RESOLUTION INQUIRING FROM THE CHAIRMAN, CITY DISASTER  
COORDINATING COUNCIL, THIS CITY, AS TO WHY MANY  
FAMILIES AFFECTED BY TYPHOON "GILAS" WERE NOT GIVEN  
ASSISTANCE BY THE CITY GOVERNMENT OF ORMOC.

WHEREAS, Typhoon "GILAS" struck Ormoc City and neighboring Visayas  
islands at noon of July 17, 2003 bringing in heavy rains and strong  
winds and caused some areas to be flooded in this city;

WHEREAS, as a result of which, many families were affected by flood  
waters, some lost their personal belongings prompting them to go to  
relocation centers for safety of their lives;

WHEREAS, the City Government of Ormoc through the City Disaster  
Coordinating Council gave assistance to the victims by way of giving  
food and other commodities;

WHEREAS, inspite of the assistance rendered by the City Government  
of Ormoc to the victims of said typhoon, many were still clamoring and  
complaining that they were not given nor received any assistance at all;

WHEREAS, because of this predicament, this august Body believes  
that said problem be attended to hence, the same be given due course of  
action;

WHEREFORE, foregoing premises considered, on motion of City  
Councilor Fe S. Lladoc, Chairman, Committee on Social Welfare, jointly  
seconded by City Councilors Rafael C. Omega, Jr. and Jovencio A.  
Laurente; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution INQUIRING FROM THE CHAIRMAN, CITY DISASTER COORDINATING COUNCIL, THIS CITY, AS TO WHY MANY FAMILIES AFFECTED BY TYPHOON "GILAS" WERE NOT GIVEN ASSISTANCE BY THE CITY GOVERNMENT OF ORMOC;
