

RESOLUTION NO. 2003-143

A RESOLUTION APPROVING ORDINANCE NO. 2003-002 OF THE  
SANGGUNIANG BARANGAY OF BARANGAY LEONDONI, THIS CITY,  
ENTITLED: "AN ORDINANCE PROHIBITING THE USE OF  
CHEMICALS, POISONOUS SUBSTANCES AND THE EMPLOYMENT OF  
ELECTRICITY, FOR THE CATCHING OF FISH AND OTHER AQUATIC  
RESOURCES IN ALL WATERS WITHIN THE JURISDICTION OF THIS  
BARANGAY."

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance No.  
2003-002 from the Barangay Council of Barangay Leondoni, entitled: "AN  
ORDINANCE PROHIBITING THE USE OF CHEMICALS AND OTHER POISONOUS  
SUBSTANCES, AND THE EMPLOYMENT OF ELECTRICITY, FOR THE CATCHING OF FISH  
AND OTHER AQUATIC RESOURCES IN ALL WATERS WITHIN THE JURISDICTION OF  
THIS BARANGAY;"

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the  
aforecited ordinance at issue (and all other ordinances of the  
Sangguniang Barangay in Ormoc City) is, by law, granted the Power to  
Review as to whether the said ordinance is consistent with law and city  
x x x ordinances; (Sec. 57, 1991 LGC)

WHEREAS, it is the observation of this august Body that the said  
ordinance has conformed to pertinent provisions of the Local Government  
Code, hence, reasonable and within the province of the Sangguniang  
Barangay of Leondoni to legislate;

WHEREFORE, foregoing premises considered, on motion of City  
Councilor Nepomuceno P. Aparis I, Chairman, Committee on Laws &  
Ordinances, jointly seconded by City Councilors Ruviniou E. Mendola and  
Fe S. Lladoc; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution APPROVING ORDINANCE NO. 2003-002 OF THE SANGGUNIANG BARANGAY OF BARANGAY LEONDONI, THIS CITY, ENTITLED: "AN ORDINANCE PROHIBITING THE USE OF CHEMICALS, POISONOUS SUBSTANCES AND THE EMPLOYMENT OF ELECTRICITY, FOR THE CATCHING OF FISH AND OTHER AQUATIC RESOURCES IN ALL WATERS WITHIN THE JURISDICTION OF THIS BARANGAY;"
