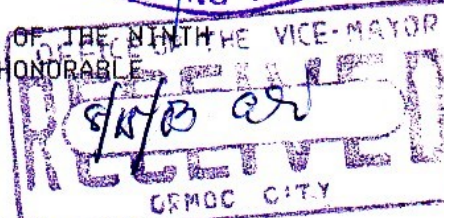

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR CARMELO J. LOCSIN TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC A FORMAL COMPLAINT AGAINST LEYECO V, CALIFORNIA ENERGY, GLOBE, SMART; GAISANO AND ALL OTHER BUSINESS ESTABLISHMENT IN THIS CITY FOR VIOLATIONS OF ORDINANCES IN THE COLLECTION OF TAXES, FEES OR CHARGES.

WHEREAS, LEYECO V, CALIFORNIA ENERGY, GLOBE and SMART have been doing business in this city for quite sometime and as such, they are subject to the city's ordinances on taxes, fees and other charges;

WHEREAS, in its exercise of authority to levy taxes, fees and other charges, the City Government of Ormoc has come up with a consensus to collect from said establishments the corresponding taxes, fees and other charges which have become due and demandable for the city's welfare;
