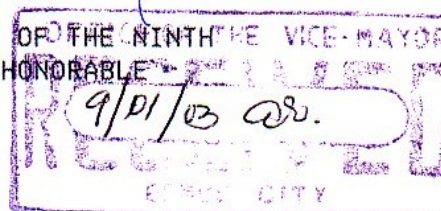

RESOLUTION NO. 2003-151

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR CARMELO J. LOCSIN, TO SIGN AND ACCEPT, A DEED OF DONATION MADE AND ENTERED INTO BY AND BETWEEN ROSETA DEJAÑO AND JEREMIAS YMAS, HEREINAFTER CALLED THE DONORS, AND BARANGAY MAGASWE REPRESENTED BY BARANGAY CAPTAIN ARTURO VILLA AND THE CITY GOVERNMENT OF ORMOC AS DONEE, INVOLVING A PARCEL OF LAND, LOT 4482-PART, PORTION OF LOT 4482, ORMOC CADASTRE, SITUATED IN BARANGAY MAGASWE, ORMOC CITY WITH AN AREA OF ONE THOUSAND ONE HUNDRED NINETY FIVE (1,195) SQUARE METERS MORE OR LESS.

WHEREAS, this Sanggunian is in receipt of an undated 1st Indorsement from the Honorable City Mayor Carmelo J. Locsin re: Deed of Donation made and entered into by and between Roseta Dejaño and Jeremias Ymas as Donors of Barangay Biliboy and Barangay Magaswe respectively, and the City Government of Ormoc represented by His Honor, Carmelo J. Locsin, City Mayor and Barangay Magaswe represented by Barangay Captain Arturo Villa involving the aforementioned parcel of land, located at said Barangay, this city;

WHEREAS, this august Body believes that said donation made by the Donors is of great help to the said barangay having been made with the object of not defrauding their creditors, having reserved to themselves property sufficient to answer for their debts contracted prior to said donation;

WHEREFORE, foregoing premises considered, on motion of City Councilor Demosthenes F. Tugonon, Chairman, Committee on Public Properties, jointly seconded by City Councilors Gregorio A. Yrastorza, Jr. and Eduardo P. Tan; be it
