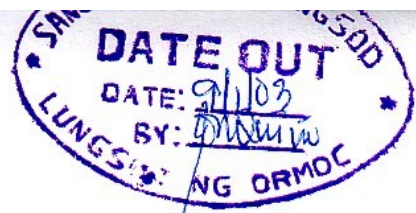
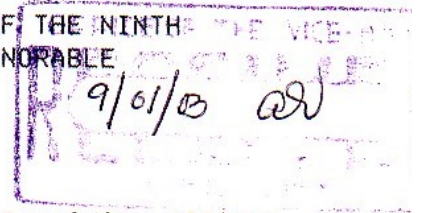

RESOLUTION NO. 2003-152

A RESOLUTION FAVORABLY ENDORSING TO THE HONORABLE CITY
MAYOR CARMELO J. LOCSIN, THE REQUEST OF THE BARANGAY
COUNCIL OF BARANGAY COGON, THIS CITY, TO APPROPRIATE
FUNDS FOR STREETLIGHTS IN ALL BARANGAYS OF ORMOC CITY
SPECIFICALLY BARANGAY COGON, TO BE TAKEN FROM THE PNOC
ROYALTY TAX FOR ORMOC.

WHEREAS, this Sanggunian is in receipt of Resolution No. 29, series
2003 of Barangay Cogon, this city, entitled: "A RESOLUTION REQUESTING
THE HONORABLE CITY MAYOR CARMELO J. LOCSIN TO APPROPRIATE FUNDS FOR
STREETLIGHTS IN ALL BARANGAYS OF ORMOC CITY SPECIFICALLY BARANGAY COGON
TO BE TAKEN FROM THE PNOC ROYALTY TAX FOR ORMOC IN THE AMOUNT OF SIXTY
SEVEN MILLION PESOS (P67,000,000.00)";

WHEREAS, with the current enforcement of LEYECO V Management of
cutting of Barangay Streetlights to eliminate systems loss, Barangay
Cogon and probably all barangays of Ormoc City will find it very
difficult to finance streetlightings due to limited financial resources;

WHEREAS, the proposal of the Barangay Council of Barangay Cogon,
this city, that the PNOC Royalty Tax for Ormoc be solely spent for
energization purposes for the benefit of all sector including the
barangays, is but reasonable, hence the same be accorded due course of
action;

WHEREFORE, foregoing premises considered, on motion of City
Councilor Fernando P. Parrilla, Councilor-in-Charge, Barangay Cogon,
this city, severally seconded by City Councilors Rafael C. Omega, Jr.,
Eduardo P. Tan and Jovencio A. Laurente; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution FAVORABLY ENDORSING TO THE HONORABLE CITY MAYOR CARMELO J. LOCSIN, THE REQUEST OF THE BARANGAY COUNCIL OF BARANGAY COGON, THIS CITY, TO APPROPRIATE FUNDS FOR STREETLIGHTS IN ALL BARANGAYS OF ORMOC CITY SPECIFICALLY BARANGAY COGON, TO BE TAKEN FROM THE PNOC ROYALTY TAX FOR ORMOC;
