AUTHORIZING THE CITY ACCOUNTANT TO CHARGE RESOLUTION AUTHORIZING THE CITY ACCOUNTANT TO CHARGE AGAINST PRIOR YEARS OBLIGATION OF THE ANNUAL BUDGET CY THE UNPAID CONTRIBUTION OF THE CITY TO REGIONAL DEVELOPMENT COUNCIL IN THE AMOUNT OF FIFTEEN THOUSAND PESOS (P15,000.00).

WHEREAS, this Sanggunian is in receipt of the 1st Indorsement dated 18 August 2003 from the Honorable City Mayor Carmelo J. Locsin requesting authority for the City Accountant to charge to account "Prior Year's Obligations" of the Annual Budget CY 2003 representing unpaid contributions of the City to the Regional Development Council in the amount of FIFTEEN THOUSAND PESOS ((P15,000.00);

WHEREAS, the City Budget Officer through 4th Indorsement dated 02 September 2003 has stated that "Request of the Honorable City Mayor hereby reiterated that authority be granted the City Accountant charge above obligation against the current appropriation-Provision for Prior-Year's Obligation - a non-office item in our CY 2003 Annual Budget;

WHEREAS, the ICO-City Treasurer through 6th Indorsement dated 02 September 2003 has stated that fund is available subject however accounting and auditing rules and procedures;
