MENDOLA HEREINAFTER CALLED THE DONOR AND BARANGAY PUNTA REPRESENTED BY BARANGAY CAPTAIN MAXIMINO JUMAO-AS AND THE CITY GOVERNMENT OF ORMOC AS DONEES, INVOLVING A PARCEL OF LAND, LOT 2349-B-1-G, SITUATED IN BARANGAY PUNTA, ORMOC CITY WITH AN AREA OF FOUR HUNDRED THIRTY SEVEN (437) SQUARE METERS, MORE OR LESS.

WHEREAS, this sanggunian is in receipt of 1st Indorsement dated 19 August 2003 from the Honorable City Mayor Carmelo J. Locsin, recommunication and Deed of Donation executed by Dolores E.
