RESOLUTION NO. 2003-157

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR CARMELO J. LOCSIN TO SIGN AND ACCEPT A DEED OF DONATION, WITH A CONDITION MADE AND ENTERED INTO BY AND BETWEEN ARTURO R. PULIDO, HEREINAFTER CALLED THE DONOR, AND THE CITY GOVERNMENT OF ORMOC AS DONEE, INVOLVING A PARCEL OF LAND LOT 2376-C-2-C, SITUATED IN BARANGAY LINAO, ORMOC CITY CONTAINING AN AREA OF ONE HUNDRED TWELVE (112) SQUARE METERS, MORE OR LESS.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 15 July 2003 from the Honorable City Mayor Carmelo J. Locsin re: Deed of Donation executed by Arturo R. Pulido, as Donor in favor of the City Government of Ormoc as Donee represented by Honorable Carmelo J. Locsin, City Mayor of a parcel of land, lot 2376-C-2-C containing an area of ONE HUNDRED TWELVE (112) SQUARE METERS located at Brgy. Linao, this city;

WHEREAS, this august Body believes that said donation made by the Donor is of great help to the City Government of Ormoc as well as to the said barangay, having been made with the object of not defrauding his creditors, having reserved to himself property sufficient to answer his debts contracted prior to said donation;
