

## RESOLUTION NO. 2003-158

AUTHORIZING THE HONORABLE CITY MAYOR LOCSIN TO SIGN AND ACCEPT A DEED OF RESOLUTION CARMELO IL DONATION, MADE AND ENTERED INTO BY AND BETWEEN NORMA TAMPOS, HEREINAFTER CALLED THE DONOR, AND THE CITY GOVERNMENT OF ORMOC AS DONEE, INVOLVING A PARCEL OF LAND LOT 5125-A-2-D-2-G, SITUATED IN BARANGAY LINAO, ORMOS CITY CONTAINING AN AREA OF SEVEN MINE (709) SQUARE METERS, MORE OR LESS.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 1 September 2003 from the Honorable City Mayor Carmelo J. Locsin re: Deed of Donation executed by NORMA TAMPOS, as Donor in favor of the City Government of Ormoc as Donee represented by Honorable Carmelo J. Locsin, City Mayor of a parcel of land, lot 5125-A-2-D-2-G, with an area of SEVEN HUNDRED NINE (709) SQUARE METERS located at Brgy. Linao, this city;
