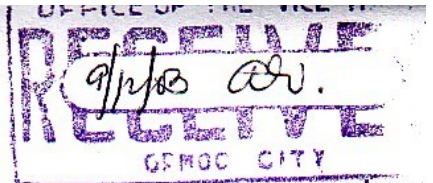

NO. 7160) REQUIRING MANDATORY COORDINATION AND CONSULTATION WITH THE APPROPRIATE LOCAL GOVERNMENT UNITS, NON-GOVERNMENTAL AND PEOPLE'S ORGANIZATIONS AND OTHER CONCERNED SECTORS AND APPROVAL OF THE SANGGUNIAN PANLUNGSOD NG ORMOC PRIOR TO THE IMPLEMENTATION OF NATIONALLY FUNDED PROJECTS/PROGRAMS AND PROVIDING PENALTIES FOR VIOLATION THEREOF" and Section 1 hereof has required "Prior Coordination, Consultation and Approval of the Sangguniang Panlungsod ng Ormoc in the implementation of Nationally Funded Projects/Programs within the territorial jurisdiction of the City of Ormoc;
