

RESOLUTION NO. 2003-162

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR CARMELO J. LOCSIN TO SIGN AND ACCEPT A DEED OF DONATION MADE AND ENTERED INTO AND BETWEEN ELESIO ARAGON, JR., HEREINAFTER CALLED THE DONOR, AND BARANGAY GUINTIGUI-AN REPRESENTED BY BARANGAY CAPTAIN TERESITA C. LAURENTE AND THE CITY GOVERNMENT OF ORMOC AS DONEE, INVOLVING PARCELS OF LAND, LOT 11531-D-1 PART WITH AN AREA OF FIFTEEN (15) SQUARE METERS, LOT 1530-PART WITH AN AREA OF THREE HUNDRED NINETY (390) SQUARE METERS, LOT 11531-D-2-PART WITH AN AREA OF FIFTY FOUR (54) SQUARE METERS, AND LOT 11529-C-PART WITH AN AREA OF TWO HUNDRED FIFTY NINE (259) SQUARE METERS, ALL SITUATED AT BARANGAY GUINTIGUI-AN, THIS CITY.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 29 August 2003 from the Honorable City Mayor Carmelo J. Locsin re: Deeds of Donation executed by Elesio Aragon, Jr., as Donor in favor of the City Government of Ormoc and Brgy. Guintigui-an as Donee represented by Honorable Carmelo J. Locsin, City Mayor and the Punong Barangay of Guintigui-an, Hon. Teresita C. Laurente respectively, involving parcels of land namely Lot 11531-D-1 Part with an area of Fifteen (15) square meters, Lot 11530-Part with an area of Three Hundred Ninety (390) square meters and Lot 11531-D-2 Part with an area of Fifty Four (54) square meters and Lot 11529-C-Part with an area of Two Hundred Fifty Nine (259) square meters all situated at Barangay Guintigui-an, this city;

WHEREAS, this august Body believes that said donation made by the Donor is of great help to the City Government of Ormoc as well as to the said barangay, having been made with the object of not defrauding their creditors, having reserved to themselves property sufficient to answer their debts contracted prior to said donation;

WHEREFORE, foregoing premises considered, on motion of City Councilor Nepomuceno P. Aparis I, Chairman, Committee on Public Properties, jointly seconded by City Councilors Ruviniou E. Mendola and Gregorio A. Yrastorza, Jr.; be it




