Councilors Fernando P. Parrilla & Ruvinieu E. Mendola; be it


RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution APPROVING

ADOPTED, September 18, 2003.



RESOLVED, FURTHER, to furnish copies of this resolution each to His
