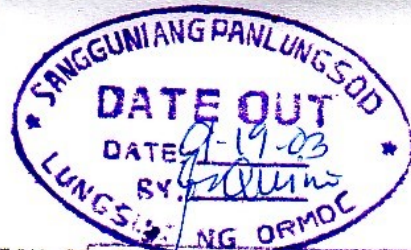
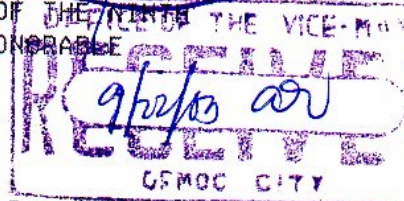

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR  
CARMELO J. LOCSIN TO REMIT THE AMOUNT OF FIVE HUNDRED  
THOUSAND PESOS (P500,000.00) TO THE COMMISSION ON  
ELECTIONS (COMELEC) FOR THE PURCHASE OF TWO (2) DATA  
CAPTURING SYSTEM MACHINES.

WHEREAS, this Sanggunian is in receipt of a letter dated 12  
September 2003 from the Honorable City Mayor Carmelo J. Locsin re:  
request for a resolution authorizing him to remit the amount of FIVE  
HUNDRED THOUSAND PESOS (P500,000.00) to the Commission on Elections  
(COMELEC) to purchase two (2) data capturing system machines;

WHEREAS, ICO - City Treasurer issued a Certificate of Availability  
of Funds dated 08 September 2003 stating that funds for obligation  
described in the above amount of Five Hundred Thousand Pesos  
(P500,000.00) is available to be sourced from Capital Outlay (Year 2000  
& 2001), Information Technology (Year 2000) and Motor Vehicle (Year  
2002);

COMELEC in relation to the validation of voters and registration of new


