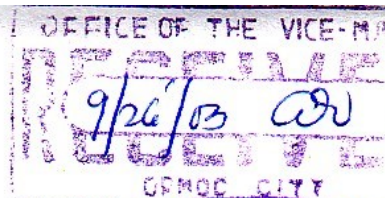

DISTRICT 18, THIS CITY;



Chairmen/Treasurers of the barangay concerned, -all in Ormoc City;


