RESOLUTION NO. 2003-172

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR CARMELO J. LOCSIN TO BE ONE OF THE PLAINTIFFS IN A PETITION FOR DECLARATORY RELIEF TO BE FILED BEFORE THE SUPREME COURT AGAINST THE DEPARTMENT OF AGRARIAN REFORM (DAR).

WHEREAS, this august Body is in receipt of a letter dated 12 September 2003 from the Honorable City Mayor Carmelo J. Locsin requesting that a resolution be passed authorizing him, in his official capacity as City Mayor to be one of the plaintiffs in a Petition for Declaratory Relief before the Supreme Court against the Department of Agrarian Reform (DAR);

WHEREAS, the same letter has further stated that the intent to pursue the said case will ultimately redound to the benefit of Ormoc City and its constituents, being one of the major sugar producing areas in the country;

WHEREAS, mindful of the plight of the sugar planters, this august Body believes that said request is reasonable, hence, the same be given due course of action;

WHEREFORE, foregoing premises considered, on motion of City Councilor Gregorio A. Yrastorza, Jr., Chairman, Committee on Agriculture, jointly seconded by City Councilors Eduardo P. Tan and Fe S. Lladoc; be it
